In terms of Regulation 30 read with Part A of Schedule III and other applicable Regulation of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that the BSE had earlier imposed a penalty of Rs.0.94 lakh for delayed compliance pertaining to filing of financial results for the quarter and half year ended September 30, 2023 and the Company had paid aforesaid penalty to BSE under protest and filed a waiver application.

The Company has received communication from BSE on February 18, 2026 stating that the waiver application filed by the Company has been rejected and confirmed the penalty of Rs.0.94 lakh which has already been paid by the Company. The delay in filing this disclosure is inadvertent and unintentional.
